Free Out-of-School Youth Services Program Serving Cumberland and Cape May Counties

Eligibility for Youth Services:

- 1. Must be ages 16 through 24
- 2. Not attending any school
- 3. AND one or more of the following:
 - a school dropout
 - youth who is withing the age of compulsory school attendance but has bot attended school for at least the most recent complete school year calendar quarter
 - a recipient of a secondary diploma or its recognized equivalent who is low-income and either basic skills deficient (reading or total math at or below 8.9 grade level) or and English Language Learner
 - an offender
 - a homeless individual or a runaway
 - an individual in foster care or who has aged out of the foster care system, or who has attained 16 years of age and left foster care for kinship guardianship or adoption; or in an out-of-home placement
 - an individual who is pregnant or parenting
 - an individual with a disability

The term "low-income" means an individual who:

- receives, or in the past 6 months has received, or is a member of a family that is receiving or in the past 6 months has received, assistance through the supplemental nutrition assistance program established under the Food and Nutrition Act of 2008 (7U.S.C. 2011 et seq.), the program of block grants to States for temporary assistance for needy families program under part A of title IV of the Social Security Act (42 U.S.C. 601 et seq.), or the supplemental security income program established under title XVI of the Social Security Act (42 U.S.C. 1381 et seq.), or State or local income-based public assistance:
- is in a family with total family income that does not exceed the higher of—
 - the poverty line; or
 - 70 percent of the lower living standard income level.
- is a homeless individual (as defined in section 41403(6) of the Violence Against Women Act of 1994 (42 U.S.C. 14043e-2(6)), or a homeless child or youth (as defined under section 725(2) of the McKinney-Vento Homeless Assistance Act (42 U.S.C. 11434a (2))).
- receives or is eligible to receive a free or reducedprice lunch under the Richard B Russell National School Lunch Act
- is a foster child on behalf of whom State or local government payments are made; or
- SPECIAL RULE- For the purpose of this subsection, the term "low-income," used with respect to an individual, also includes a youth living in a highpoverty area. [WIOA Sec. 3 (36) (A)]
